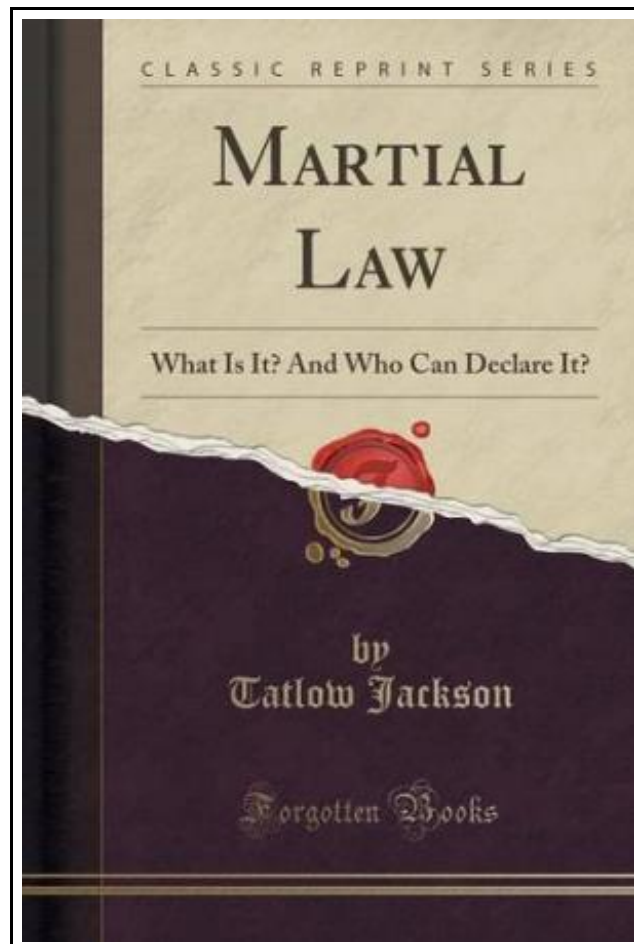

He may put to death, or to other bodily punishment, whom he shall think so to deserve, without process of law, or form of judgment.
