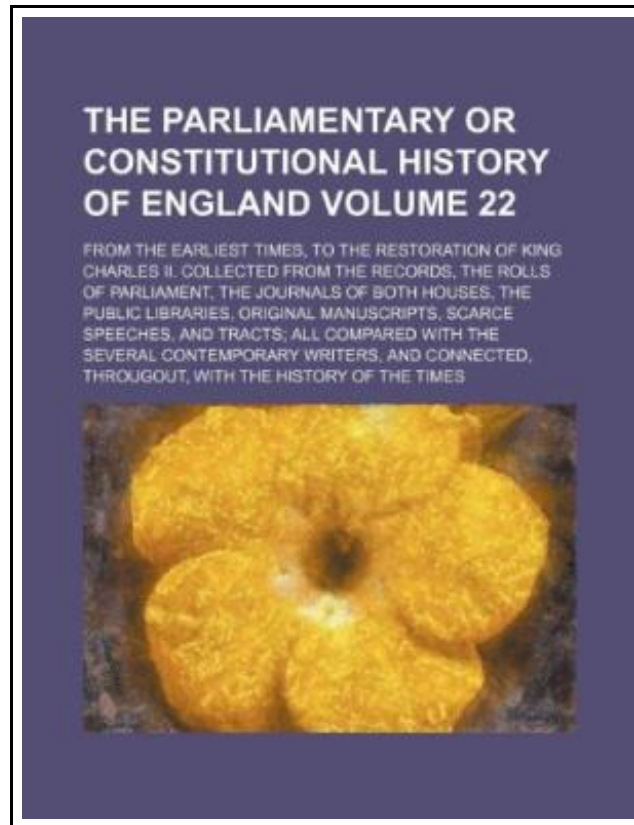

Given at our Court at Breda the 11th Day of April, 1660, in the twelfth Year of our Reign. After reading these Letters, with the Declaration, in the two Houses, the Lords ordered Sir John Greville to be called in again, and the Speaker, by Direction of the House, gave him Thanks, in their Name, for his Care in bringing this gracious Message from the King. They also ordered, That the King's Letter to them and the Declaration should be forthwith printed and published, with this Title, His Majesty's gracious Letter and Declaration, sent to the House of Peers by Sir John Greville, Knt. Lastly, the Lords appointed a Committee to consider of a Letter of Thanks to the King for his gracious Message sent, this Day, to the House, and to present it for their Lordships Consideration.
